विषय:- Suspension from bidding in CPWD tenders for a period of one year in respect of M/s MaX Tech Infra Projects Pvt. Ltd. having registered office at H. No. A-3, New Millat Colony, Sector-2, Phulwari Sharif, Patna (Bihar)-801505.

महोदय,

Whereas the tender was invited by the Executive Engineer, Ranchi Project, CPWD, Airport Road, Hinoo, Ranchi, Jharkhand-02, vide NIT No. 02/NIT/EE/RP/CPWD/2021-22 for the work "Augmentation of capacity (150 KLD) of Sewerage Treatment Plant based on MBBR Technology including design, supply, installation, testing and commissioning at 2nd Reserve Bn., CISF, Ranchi (Jharkhand)."

Whereas the financial bid of the above tender was opened on 10.12.2021 and the lowest bidder was M/s MaX Tech Infra Projects Pvt. Ltd. having registered office at H. No. A-3, New Millat Colony, Sector-2, Phulwari Sharif, Patna (Bihar)-801505

Whereas M/s MaX Tech Infra Projects Pvt. Ltd. having registered office at H. No. A-3, New Millat Colony, Sector-2, Phulwari Sharif, Patna (Bihar)-801505 had submitted Earnest Money Deposit (EMD) declaration along with their tender, which states that:-

"(1) If after the opening of tender, I/we withdraw or modify my/our bid during the period of validity of tender (including extended validity of tender) specified in the tender documents,

(2) If after the award of work, I/we fail to sign the contract, or to submit performance guarantee before the deadline defined in the tender documents

I/we shall be suspended for one year and shall not be eligible to bid for CPWD tenders from date of issue of suspension order."

Whereas the tender was accepted by the competent authority and the Executive Engineer, Ranchi Project, CPWD, Airport Road, Hinoo, Ranchi, Jharkhand-02 vide letter No. 54(CISF-STP)/বাঁoपo/2021/2848-61 dated 10.12.2021 requested you to deposit the performance guarantee within 7 (Seven) days from issue of the acceptance letter and further with @ 0.1% per day of Performance Guarantee amount upto the extended date of 19.12.2021.

Whereas you have failed to submit the "Performance Guarantee" within stipulated date as per NIT and withdrawn your bid as per your letter no. nil dated 16.12.2021.

Whereas it appears to the undersigned that by reason of your wrongful violation of EMD declaration submitted by you along with the tender of above cited work. You had committed breach of NIT conditions.

Whereas a notice was issued to M/s MaX Tech Infra Projects Pvt. Ltd. having registered office at H. No. A-3, New Millat Colony, Sector-2, Phulwari Sharif, Patna (Bihar)-801505 vide T.O. letter No. 54(CISF-STP)/গাঁ০ঘ০/2021/2961-62 dated 20.12.2021 (by speed post as well as e-mail) to show cause why action for suspension from bidding in CPWD tenders for a period of one year should not be taken against them on account of violation of EMD declaration.

Whereas no reply was submitted by M/s MaX Tech Infra Projects Pvt. Ltd. having registered office at H. No. A-3, New Millat Colony, Sector-2, Phulwari Sharif, Patna (Bihar)-801505 till date so the case is closed.

Therefore, I, Sumit Saurabh, Executive Engineer, Ranchi Project, CPWD, Airport Road, Hinoo, Ranchi, Jharkhand - 834004 hereby suspend M/s MaX Tech Infra Projects Pvt. Ltd. having registered office at H. No. A-3, New Millat Colony, Sector-2, Phulwari Sharif, Patna (Bihar)-801505 from bidding in CPWD tenders for a period of one year from the date of issue of this order.
