**OFFICE ORDER**

Sub: Debarment for six months from tendering process in CPWD in respect of H A Vinod Kumar, Enlisted Class-III (B&R Category) Contractor in CPWD

1. Whereas, **H A Vinod Kumar, No: 49/A, Maruti Temple Road, Kuvempunagar, Mysore, Karnataka – 570 009** is an enlisted contractor under Class-III, Building & Roads category issued vide enlistment order No. 55(11)28/2021/ADG(RB) /1330-31(H) dated 28.06.2022 which is valid for 5 years from the date of issue of this authority i.e., up to 27.06.2027. The above order stipulates that the enlisted contractor shall abide the Enlistment Rules of CPWD as amended from time to time.
2. Whereas, H A Vinod Kumar has submitted an online application for Enlistment in CPWD as Class I in Buildings& Roads category with address 49/A, Maruti Temple Road, Kuvempunagar, Mysore, Karnataka – 570 009, through CEMS portal on 29.06.2024 along with required documents as per Rules for Enlistment of Contractors in CPWD 2023.
3. Whereas, H A Vinod Kumar has submitted a GST Certificate dated 24.03.2024 along with the enlistment application wherein the address mentioned is No. 167, CH-29,11th main, Saraswathipuram, New ward no. 21, Mysore, Karnataka- 570 009, but the same is found to be different from the address mentioned in the Enlistment Order mentioned in para 1 above and as provided in the newly submitted application (Annexure-I) by the contractor. This office, vide letter no. 55(11)-B&R-I-454/ಅ.ಮ.ನಿ(ಬೆ.)/2024/2233(H) dated 19.07.2024 has sent this observation along with other observations to the applicant for clarification.
4. Whereas, H A Vinod Kumar has replied on 02.08.2024 through CEMS portal, by submitting an old GST certificate issued on date 28.09.2023 having address of 49/A, Maruti Temple Road, Kuvempunagar, Mysore, Karnataka – 570 009. The replies to the queries were not found satisfactory and when the GST certificate was verified online through GST portal, the address is found to be 167, CH-29,11<sup>th</sup> main, Saraswathipuram, Mysore New ward no.21, Mysore, Karnataka- 570 009 and not the address mentioned in the application submitted for enlistment in Class-I.
5. Whereas, H A Vinod Kumar has not furnished any document till date regarding giving intimation for change of address to the Enlisting Authority or any approval granted by the Enlisting Authority. Thus, H A Vinod Kumar has not intimated the Enlistment Authority about change of address.
6. Whereas, the responsibility to abide by conditions of enlistment lies with enlisted contractor, H A Vinod Kumar and it appears that H A Vinod Kumar has not abided by the conditions mentioned at s.no.2 in his Enlistment Order 55(11)28/2021/ADG (RB)/1330-31(H) dated 28.06.2022. As such, H A Vinod Kumar has made himself liable for disciplinary action as per the prevailing Enlistment Rules for not abiding to the conditions of enlistment order and invites disciplinary

action as per rule 13.6(c) and 13.6(h) of Rules for Enlistment of Contractors in CPWD 2023/2024 (ER 2023/2024).

7. Whereas, the Enlisting Authority therefore has decided to refer the case to the Empowered Committee as per Rule 13.0 of ER 2023/2024 for taking disciplinary action for not complying rule 9.3 of ER 2023/2024. The Empowered Committee has decided to issue a show cause notice to the enlisted entity and accordingly as per rule 13.7.1 of ER 2023/2024, a show cause notice was served to H A Vinod Kumar by the Member Secretary of the Empowered Committee vide letter no. 55(11)-B&R-I-454/ADG(B)/2024/ 832-34 (H) dated 10.03.2025.
8. Whereas, H A Vinod Kumar has replied to the show cause notice vide letter no. Nil dated 12.03.2025 received in this office through e-mail. In his reply, H A Vinod Kumar admitted that he has changed his address from 'No. 49/A, Maruthi Temple Road, Kuvempunagar, MYSORE, Karnataka -570 009' to 'No. 167, CH-29, 11th main, Saraswathipuram, Mysore New ward no. 21, Mysore, Karnataka- 570 009' and submitted that he was not aware to notify the authorities about the change of address.
9. Whereas, after due deliberations and by considering the facts on records & the reply by H A Vinod Kumar, the Empowered Committee has established that H A Vinod Kumar has
  - i. Failed to abide by the conditions of enlistment - **Violation of Rule-13.6(c) of ER 2023/2024**
  - ii. Did not give intimation of change of address which otherwise should be given within one of such change along with acknowledgement of noting down such change from Bank, Income Tax, GST authorities, etc. - **Violation of Rule-13.6(h) of ER 2023/2024**Therefore, the Committee recommended for debarment of H A Vinod Kumar for 6 months which entails the enlisted entity i.e., H A Vinod Kumar from not allowing to participate in CPWD tendering process for six months.
10. Whereas, the Disciplinary Authority has carefully considered the proceedings of the Empowered Committee, the reply of the contractor, H A Vinod Kumar and the final recommendation of the empowered Committee.

Based on the recommendations of the Empowered Committee, the Enlisting Authority who is also the Disciplinary Authority as per provisions contained under para 13.1 and 13.2 of ER 2023/2024, has ordered for debarment of **H A Vinod Kumar, 49/A, Maruti Temple Road, Kuvempunagar, Mysore, Karnataka - 570 009** for a period of 6 months from participating in the tender process in CPWD with immediate effect i.e., from the date of issue of this office order. Whereas, H A Vinod Kumar may apply for affecting the change of address as per Rule 9.3 of Rules for Enlistment of Contractors in CPWD 2024 immediately.
