Whereas, tender was floated vide NIT No. 03/EE&SM(E)/IITPED/2021-22 for the work of C/o Engineering Block - 99B and 99C at IIT Delhi including Water Supply, Sanitary Installations, Electrical Installation, DG Set, Substation, HVAC, Fire Alarm, Fire Fighting System, Lifts and IBMS (SH:-Providing services of office assistance staff).

Whereas, the above tender was opened on 01.11.2021 in which the agency M/s Saud Mirza, 2nd, D-66/1, Thokar No.8, Shaheen Bagh, Abul Fazal Enclave Part-II, Jamia Nagar, Okhla, South East Delhi, Delhi, 110025 was found lowest bidder. The letter for submission of performance guarantee of Rs. 55,260/- has been sent vide this office letter no. 54(1)/का.अभि.(वै)/आई.आई.टी. परि० वै० म०/2021/576 दिनांक:- 08.11.2021. But the agency neither submitted performance guarantee nor shown any willingness to execute the work.

This CPWD agency has signed the declaration and uploaded it in lieu of EMD which states that If, I/we fail to sign the contract or to submit performance guarantee before the deadline defined in the tender documents, I/we shall be suspended for one year and shall not be eligible to bid for CPWD tenders from date of issue of suspension order.

Whereas, this declaration and its conditions were incorporated in the NIT on the basis of CPWD OM No. DG/CON/Misc./13 dated- 23/11/2020.

Therefore, the agency M/s Saud Mirza is hereby suspended for one year from the date of issue of this OM and shall not be eligible to bid for CPWD tenders during this period.
