Sub: - Suspension from bidding in CPWD tenders for a period of one year in respect of Mohd. Furquan Quadri.

Whereas a tender was invited by the Executive Engineer-I, C.P.W.D., Bhopal, Nirman Sadan, Arera Hills, Bhopal – 462011, vide NIT No. 14/EE-I/Bhopal/2021-22 for the work “ Construction of 01 No. Temporary shed for composting pits at IISS, Bhopal”.

Whereas the bid of the above tender was opened on 26.07.2021 and the lowest bidder was Mohd. Furquan Quadri, 150-B, Bagh Rani Sahiba, Naveen Nagar, Bhopal - 462001.

Whereas the Mohd. Furquan Quadri, 150-B, Bagh Rani Sahiba, Naveen Nagar, Bhopal – 462001 has submitted Earnest Money Deposit (EMD) declaration along with their tender, which states that :-

(1) *If after the opening of tender, I/we withdraw or modify my/our bid during the period of validity of tender (including extended validity of tender) specified in the tender documents.*

Or

(2) *If, after the award of work, I/we fail to sign the contract, or to submit performance guarantee before the deadline defined in the tender documents, I/we shall be suspended for one year and shall not eligible to bid for CPWD tenders from date of issue of suspension order.*

Whereas Mohd. Furquan Quadri, failed to deposit the Performance Guarantee within the specified period mentioned in the NIT.

Whereas, a notice was issued to Mohd Furquan Quadri vide letter no. 23(IISS)/BCD-1/2021-22/2655 H dated 24.12.2021 to show cause why action for suspension from bidding in CPWD tenders for a period of one year should not be taken against them on account of violation of EMD declaration.

Whereas the reply submitted by Mohd Furquan Quadri, vide their letter number nil dated 04.01.2022, received on 04.01.2022, 09.37 AM through mail has been considered carefully and has not been found satisfactory.

Therefore, I Yash Gupta, Executive Engineer-I, CPWD, Bhopal, Nirman Sadan, Arera Hills, Bhopal -462011 hereby suspended Mohd Furquan Quadri, 150-B, Bagh Rani Sahiba, Naveen Nagar, Bhopal - 462001 from bidding in CPWD tenders for a period of one year from date of issue of this order.
