**Sub: Suspension from bidding in CPWD tenders for a period of one year in respect of M/s Arise Constructions.**

Whereas a tender was invited by the Executive Engineer, (O/o Executive Engineer, Hyderabad-I, CPWD, Hyderabad), vide NIT no ...43/2021-22/Hyd-I/Hyderabad for the work of construction of floor partition at Nutrition shed at DPR New Campus, Rajendranagar, Hyderabad.

Whereas the financial bid of the above tender was opened on 21.08.2021 and the lowest bidder was M/s Arise Constructions, E-6A/229B, Sangam Vihar, South Delhi, New Delhi – 110 062.

Whereas M/s Arise Constructions, E-6A/229B, Sangam Vihar, South Delhi, New Delhi – 110 062. had submitted Earnest Money Deposit (EMD) declaration along with their tender, which states that:

“(1) If after the opening of tender, I/we withdraw or modify my /our bid during the period of validity of tender (including extended validity of tender) specified in the tender documents,

Or

(2) If, after the award of work, I/we fail to sign the contract, or to submit performance guarantee before the deadline defined in the tender documents.

I/We shall be suspended for one year and shall not be eligible to bid for CPWD tenders from date of issue of suspension order.

Whereas M/s Arise Constructions, E-6A/229B, Sangam Vihar, South Delhi, New Delhi – 110 062 failed to deposit the Performance Guarantee within the specified period mentioned in the NIT.



Whereas a notice was issued to M/s Arise Constructions, E-6A/229B, Sangam Vihar, South Delhi, New Delhi – 110 062 vide letter number 54(DPR)2021/HCD I/1310 dated 03.11.2021 to show cause why action for suspension from bidding in CPWD tenders for a period of one year should not be taken against them on account of violation of EMD declaration.

Whereas the reply submitted by M/s Arise Constructions vide their letter number nil dated 11.11.2021 has been considered carefully and has not been found satisfactory.

Therefore I, (Ryaka Devadas, Executive Engineer, Hyderabad-I, CPWD, Hyderabad), hereby suspend M/s Arise Constructions, E-6A/229B, Sangam Vihar, South Delhi, New Delhi – 110 062 from bidding in CPWD tenders for a period of one year from the date of issue of this order.


