विषय: Suspension of Non-CPWD agency M/s. Hindustan System, Bhopal for one year.

Whereas, tender was floated vide NIT No. 07/EE(E)/PED/NIT/2021-22 for the work of "Installation of rooftop solar panel work at C-MET, Pashan, Pune."

Whereas, the above tender was opened on 17/08/2021 in which the agency M/s. Hindustan System, Proprietor Shri. Rajendra Prasad Patel, UG-25 Kartar Arcade, Near Capital Petrol Pump, Raisen Road, Bhopal - 23 (M.P.) was found lowest bidder. The work was awarded to the agency vide letter No. 54(1791)/PCED/2021-22/1292-98-Hi dtd. 20/08/2021. The agency has shown unwillingness to execute the work vide his letter No. HS/SOLAR/BPL/2021/L575 dated- 01/09/2021 and is not responding to any communication made by this office vide letter No. (i) 54(1791)/PCED/2021-22/11404-06-H dated- 09/09/2021 & (ii) 24(262)/पुवैम/योशा/2021/1567-69 dated- 07/10/2021. This non-CPWD agency has signed the declaration and uploaded it in lieu of EMD which states that if I/we withdraw or modify my/our bid during the validity period of the tender (i.e. 30 days in this case), I/we shall be suspended for one year and shall not be eligible to bid for CPWD tenders from date of issue of suspension order.

Whereas, this declaration and its conditions were incorporated in the NIT on the basis of CPWD OM No. DG/CON/Misc./13 dated- 23/11/2020.

Therefore, the agency M/s. Hindustan System is hereby suspended for one year from the date of issue of this OM and shall not be eligible to bid for CPWD tenders during this period.
