Sub: Suspension from bidding in CPWD tenders for a period of one year in respect of "M/s Mohammad Naseem"

Whereas a tender was invited by the Executive Engineer(Lucknow)-I, CPWD, Lucknow Pin code-226024, vide NIT no. 27/EE/Lucknow-I/2021-22 for the work of "Upgradation and alteration work (Civil & Electrical) of residential quarter at Akanksha Parisar, Pocket-B, Jankipuram, Lucknow during 2021-22 (SH: Upgradation of Type-V-10 No. Quarters)".

Whereas the financial bid of the above tender was opened on 20.10.2021 and the lowest bidder was M/s Mohammad Naseem, Avadh Enclave, H.No. 602/1967, Madarsa wali road, Hardoi road, Dubagga, Lucknow.

Whereas, M/s Mohammad Naseem, Avadh Enclave, H.No. 602/1967, Madarsa wali road, Hardoi road, Dubagga, Lucknow had submitted Earnest Money Deposit (EMD) declaration along with their tender, which states that:

- (1) If, after the opening of tender, I/we withdraw or modify my/our bid during the period of validity of tender (including extended validity of tender) specified in the tender documents,

OR

- (2) If, after the award of work, I/we fail to sign the contract or to submit performance guarantee before the deadline as defined in the tender document,

I/we shall be suspended for one year and shall not be eligible to bid for CPWD tenders from date of issue of suspension order.

~~Whereas while the acceptance of tender was in process and during the period of validity of tender..... (Name of agency) vide their letter number dated..... addressed to the Executive Engineer/Assistant Engineer....., withdrawn/modify their bid during the period of validity of tender.~~

Whereas M/s Mohammad Naseem, failed to deposit the Performance Guarantee within the specified period mentioned in the NIT as such vide your letter no. Nil dated 15.11.2021, it was intimated by you that you are unable to execute the work due to poor rate quoted by you. It was also requested by you to cancel the NIT/Agreement.

Whereas a notice was issued to M/s Mohammad Naseem, vide letter number 3759 dated 17.11.2021 to show cause why action for suspension from bidding in CPWD tenders for a period of one year should not be taken against them on account of violation of EMD declaration.

Whereas the reply submitted by M/s Mohammad Naseem, vide their letter number NIL dated 17.11.2021 has been considered carefully and has not been found satisfactory ~~has been found satisfactory and the case is closed.~~
