

Whereas the tender was invited by the Executive Engineer, Amritsar Division, CPWD, 2/1-Ram Tirath Road, Amritsar, vide NIT no. 01/EE-AMRITSAR/2021-22 for the work Design, Supply, Installation, Testing and Commissioning of 95 KLD STP cum ETP in ESI Hospital, Majitha Road, Amritsar.

Whereas the financial bid of the above tender was opened on 16.06.2021 and the lowest bidder was M/s. Ecologics India Private Limited, Plot No. 3189, Ground Floor, Sushant Lok-II, Sector-57, Gurugram, Haryana-122002.

Whereas M/s. Ecologics India Private Limited, Plot No. 3189, Ground Floor, Sushant Lok-II, Sector-57, Gurugram, Haryana-122002 had submitted Earnest Money Deposit (EMD) declaration along with their tender, which states that:

- (1) If after the opening of tender, I/we withdraw or modify my/our bid during the period of validity of tender (including extended validity of tender) specified in the tender documents,
- or
- (2) If, after award of work, I/we fail to sign the contract, or to submit performance guarantee before the deadline as defined in the NIT/bid document.

I/we shall be suspended for one year and shall not be eligible to bid for CPWD tenders from the date of issue of suspension order.

Whereas M/s. Ecologics India Private Limited, Plot No. 3189, Ground Floor, Sushant Lok-II, Sector-57, Gurugram, Haryana-122002 failed to deposit the Performance Guarantee within stipulated date as per NIT.
