- 1. SE, President Estate Circle, CPWD, New Delhi vide letter no. 23(16)/सहा.अभि.(यो) / रा.स. / मूल क (हि) / 1100 dated 23.09.2020 has requested to take necessary disciplinary action against Sh. Atam Parkash, 5A/82, W.E.A., Karol Bagh, New Delhi-110005. Consequent upon identifying followings given below:
 - a. Non Performance of contract & delaying of work agreement no. 13/EE/PED/2018-19 & Name of work "A/R & M/o building, Rashtrapati Bhawan in Schedule-A Preseident Estate, New Delhi 2018-19 (Sh. Repair of work for attending major complaints).
 - b. False claims of refund of EMD deposited for NIT No. 123/EE/PED/2011-12 (Pay Order No. 985543 dated 22.03.2012 which already refunded to you on 26.03.2012.
 - c. Non compliance of agreement terms & conditions such as non applying of EOT/milestone cases, non obtain labour clearance certificate & over claim / false of bills for works executed under contracts (i) 03/EE/PED/2012-13 (ii) 05/EE/PED/2009-10 (iii)07/EE/PED/2009-10 (iv) 56/EE/PED/2013-14 & 57/EE/PED/2013-14.
- 2. Whereas Sh. Atam Parkash, 5A/82, WEA, Karol Bagh, New Delhi-05 is registered in Class-IV (Civil) Category contractor vide office order no. 10(1)/91-A&C (NDZ-III)/3012 Dated 23.06.2011 of CE, NDZ-III, CPWD, New Delhi. The above order stipulate that the agency is bound by enlistment rules of CPWD as amended from time to time & they shall have to abide by ferms & conditions of agreement/contract/NIT.
- Whereas as per condition under para-5 & 12 of aforesaid enlistment order as per clause 23.1, 23.2,
 23.3 of Enlistment Rules 2005 (Updated Rules 2017, 2019 & 2020) & Clause 13.6 & 13.7 (a) (b) (c) of Rules for Enlistment of contractor 2020 in CPWD). The enlisted contractor fails to execute

contract or executes it unsatisfactorily & violates any important conditions of contract than it will render suspension of business/cancellation of enlistment.

- Show cause notice was issued vide letter 14(30)/Atam Parkash/Emp.Comm./NDZ-I/2021-485 dated 01.03.2021 that why suitable action should not be taken against you due to lapses/misconduct on your part.
- 5. You have submitted reply to above show cause notice vide letter no. Nil & dated 16.03.2021. The empowered committee, who is its meeting held on 07.04.2021 after due deliberation by considering your reply to show cause notice & other facts on record has found that the agency failed to perform the agreement, delayed work, failed to submit various documents & submission as per clause 5, 12, 36, 45 of G.C.C. of the agreements & submission of claims which already been released to agency.
- 6. All documents, your reply & recommendations of the empowered committee has been carefully examined by ADG(RD). Now in terms of the provisions contained in para/clause 13.6 Rules for enlistment of contractors in CPWD 2020. The Enlistment Authority i.e. Additional Director General (Region Delhi), CPWD, New Delhi decided to suspend your enlistment for 01(One) years from date of issues of this letter.

This issues with the approval of ADG(RD).
