OFFICE ORDER No. \ 30 (Horticulture) dated 30 \4/2019

- 2. a) They shall be required to deposit earnest money with each tender as per terms and conditions of the Notice Inviting Tenders.
 - b) Security Deposit will be recovered from their bills in accordance with the rules in force from time to time.
- 3. They are required to participate in tendering in CPWD and secure works in the Department. In case they fail to secure appropriate works of specified magnitude during the period of enlistment/ revalidation, the request for further revalidation of enlistment of the contractor shall be dealt as per Enlistment Rules applicable at that time.
- 4. They shall be required to continue to have a permanent Engineering Organization with at least minimum number of engineering personnel and minimum tools & plants as per provisions of Enlistment Rules 2017 & further amendments thereof made from time to time. They shall be required to intimate changes in their Engineering Staff and / or tools & plant as and when such changes are made.
- 5. They shall employ the required technical staff and/ or tools & plants as per terms and conditions of each contract / agreement.
- 6. They shall have to abide by the terms and conditions of the NIT/Contract/Agreement as they stand or as may be altered from time to time.
- 7. They shall be issued tender on production of valid enlistment order.
- 8. They shall not modify the existing partnership or enter into any fresh partnership or change in the name of firm without prior approval of the enlistment authority. Such proposal, if any shall be submitted in advance giving full details of the intended partnership / sole proprietorship or change in name of firm along with the draft partnership deed / affidavit and documents as required. Any change in status of the contractor as an "individual" or in constitution of the firm or change in the name of firm without prior approval of the enlistment authority will render the contractor/firm liable to be removed from the approved list of contractors.
- 9. They shall not be permitted to tender for works in the CPWD Circle responsible for award and execution of contract in which their near relative is posted as Divisional Accountant or as an Officer between the grades of SE & JE (both inclusive). They shall also intimate to the Directorate of CPWD & Enlisting Authority, the names of persons
