ORDER OF DEBARMENT

All concerned are informed that M/s Sheema & Company, sole proprietor Sh. Shamsi Ahmad Farooqui S/o Late Q. A. Farooqui R/o Gandhi road, Sadar, Ghazipur (UP) had submitted fake/false FDRs/TDRs with details as (i) EM/TDR/F/No/ 431188 dated 06.11.2018 amounting to Rs. 3,25,000/- and (ii) EM/TDR/F/No. 431325 dated 27.12.2018 amounting to Rs. 6.00 lakh (both pledged in favour of Executive Engineer, BHU Project Division-II, CPWD, Varanasi) in the office of Executive Engineer (E), BHU Project Electrical Division, CPWD, Varanasi against EMD/P.G. for the work of "C/o Development E&M Services for faculty of Veterinary & Animal Sciences Campus at RGSC (BHU), Barakachha, Mirzapur (SH: SITC of High Mast & LED Street light)." A show cause notice was issued to the agency to explain as to why he should not be removed from the approved list of contractors, vide this office letter no. 5(9)/E&R/Class-III(Composite)/ADG(NR-II)/649 dated 15.04.2019. However, the cause / reply submitted by the agency vide their letter no. Nil dated 18.05.2019 is not found satisfactory by the Enlisting Authority and the firm is found guilty of submission of fake/false FDRs.

Therefore, M/s Sheema & Company, sole proprietor Sh. Shamsi Ahmad Farooqui S/o late Q.A. Farooqui R/o Gandhi road Sadar, Ghazipur (U.P.) is debarred from tendering/removed from the approved list of Class-III (Composite) category of CPWD as per Enlistment Rule No. 23.3(F)/ER 2017 for a period of 3 years from the date of issue of this order or till further orders, whichever is earlier.
