## OFFICE ORDER No. 52/2021

Sub:- Cancellation of Enlistment Registration under Class-IV(Building, formerly Composite) Category Contractor in CPWD in r/o shri. Krishna Chandra Pariccha.

- Chief Engineer-Bhubaneswar, CPWD, Bhubaneswar vide Lr. No. 59(2)/CEa. BBRS/2021/86, dt: 20.01.2021 has requested to take necessary disciplinary action against shri. Krishna Chandra Pariccha, Plot No: LIG-148, housing Board Colony, Charbatia, (Dt.) Cuttack, Odisha-754028, consequent upon identifying forgery/ falsification of EMD instrument in the bid submitted by the agency for the work of "Renovation of front phase of Heritage building at Ganghadar, Mehar University, Sambalpur, Odisha, NIT No: 02/NIT/Sambalpur/CPWD/2021".
- Whereas, shri. Krishna Chandra Pariccha, Plot No: LIG-148, housing Board b. Colony, Charbatia, (Dt.) Cuttack, Odisha-754028, was registered in Class-IV (Composite) category vide Enlistment order No: 59(2)KP/SE-BCC/2018/82-89(H), dt: 30.01.2018 for a period of 5 (Five) years. The above order stipulates that the agency is bound by the Enlistment Rules of CPWD as amended from time to time.
- Whereas, as per the condition under Para No.11 of the aforesaid enlistment C. order and as per Para No.23.3 of Enlistment Rules, 2005(updated Enlistment Rules, 2019 as well as 2020), the enlisted contractor shall not indulge in any type of forgery or falsification of records, which will render his enlistment for cancellation from list of CPWD enlisted contractors.
- A Show cause notice was issued by this office vide Lr. No.16(1)/ADG-RH/ d. CPWD/ 2021/564 dated 23.03.2021 to the agency requesting to show cause as to "why disciplinary action should not be taken against you and also why you should not be removed from the list of enlisted contractors of CPWD as per Para 23 of Enlistment Rules-2019 and para 13.7 of Enlistment Rules -2020", for which reply was received from the agency vide his Lr. No: 05/KCP/2021, dt: 05.04.2021. The reply of the agency has not been found satisfactory.

- e. The issue was placed before empowered Committee, who in its meeting held on 02.07.2021 after due deliberations and by considering the facts on records has found that shri. Krishna Chandra Pariccha, Charbatia has committed wrongful action of forgery and falsification of EMD instruments.
- f. Now, Therefore, in terms of the provisions contained in Para No.23.3 of Enlistment Rules,2005(updated Enlistment Rules,2019 as well as 2020), the Enlistment Authority i.e., Additional Director General, Region Hyderabad, CPWD, Hyderabad is pleased to remove the name of shri. Krishna Chandra Pariccha, Plot No: LIG-148, housing Board Colony, Charbatia, (Dt.) Cuttack, Odisha-754028 from the approved list of Class-IV(Building, formerly Composite) Category Contractors in CPWD with immediate effect.
