**OFFICE MEMORANDUM****Sub: - Suspension of business with CPWD in respect of M/s Roy Electric Works.**

Whereas a tender was floated by the Executive Engineer(E), Ghaziabad Electrical Division, CPWD, Air Force Station Hindan, Ghaziabad-201004, vide NIT No. 06/EE(E)/HCED/CPWD/2021-22 for the work "Special repair to electrical substation, Power supply and earthing, infra structure at HAF, Hindan, GZB (SH:- LT cable laying from S/Stn. No. 13 to 129 HU Balance work)"

Whereas the lowest bidder was M/s Roy Electric Works, D-391, Pul Pehladpur, Badarpur, New Delhi-110044 and Executive Engineer(E), Ghaziabad Electrical Division, issued him a letter No. 54(03)/AE(E)-2/Hindan / 21-22/1102 (Hindi) dated 08.06.2021 for submission of Performance Guarantee by 14.06.2021 and further upto 17.06.2021 with late fee.

Whereas M/s Roy Electric Works D-391, Pul Pehladpur, Badarpur, New Delhi-110044 has signed the declaration for earnest money deposit, which states that after the awards of work, if they fail to sign the contract or to submit performance guarantee before the deadline defined in the tender documents, they shall be suspended for one year and shall not be eligible to bid for CPWD tenders from date of issue of suspension order.

Whereas M/s Roy Electric Works failed to submit the "Performance Guarantee" within the stipulated / extended date i.e. 17.06.2021.

Whereas a show cause notice was served to the agency vide this office letter No. CSQ(CM)/5(1)/Debar/2021/599 dated 11.08. 2021.

Whereas the reply submitted by agency vide letter No. Nil dated 20/08/2021 was considered and not found satisfactory.

M/s Roy Electric Works D-391, Pul Pehladpur, Badarpur, New Delhi-110044 has committed a breach of terms of NIT/ contract.

Therefore I, Vinayak Rai, Chief Engineer(CSQ), CPWD, Nirman Bhawan, New Delhi hereby suspend M/s Roy Electric Works, D-391, Pul Pehladpur, Badarpur,

New Delhi-110044 from bidding in CPWD tenders for one year from the date of issue of this order.
