विषय: Debarment of contractor for a period of 6 months in respect of M/s Dushyant Enterprises Class-III(B&R) Category, Ghaziabad.

Name of Work (1):- Installation of Porta Cabin for staying of Security Guard/ Police Officials for security purpose to prevent theft in the area in 1192 T-II, 756 T-IV Laxmi Bai Nagar and 210 D-II Flat West Kidwai Nagar, New Delhi during 2022-23 -(Regarding PG Forfeiture) Agreement No. 14/EE/T-Divn/2022-23

Name of Work (2):- A/R & M/O to 405 DA Flats Kalyanvas at Delhi during 2021-22 (SH:- Misc. civil repair work to attend major complaints white washing/painting cleaning of overhead tank etc.)- (Regarding work Rescinded) Agreement No. 44/EE/EBMDM-221/PWD/GNCTD/2021-22

1- Whereas Performance Guarantee of M/s Dushyant Enterprises was forfeited by the EE(T Division), CPWD, R.K.Puram, New Delhi vide letter No. 54(14)/ ले.शा./टी.मं./ 2022 / 2792 दिनांक 22.08.2022 for work mentioned at S.No.(1) due to not starting the work. The copy of this letter was send to this office for taking appropriate action being enlistment authority. The case was putup before empowered committee and in terms of rule no. 13.2 of enlistment rules 2022 a show cause notice was issued to said contractor vide this office letter no. 5(9)/Class-III(B&R)/ER-2021/ADG(Lko)/2022/4692 dated 07.09.2022. Reply of this show cause notice was received in this office on 04.10.2022 from contractor, which was found unsatisfactory.

2- Whereas again a letter received from Asstt. Director O/o Pr. Chief Engineer (M&F) PWD, Govt of NCT of Delhi vide letter no. 23(26)/Pr.CE(M)/PWD/4257 dated 02-09-2022, in which it is mentioned that said contractor has been failed to execute the work mentioned in S.No. (2) above. The complete case was putup before empowered committee and in terms of rule no.13.2 of enlistment rules 2022 a show cause notice was issued to said contractor vide this office letter no. 5(9)/Class-III(B&R)/ER-2021/ADG(Lko)/2022/5294 dated 14.10.2022. Reply of this show cause notice was received in this office through email dated 19.10.2022 from contractor, in which contractor has mentioned that work has already been completed upto 75% as on 01.03.2022 and bill was submitted in Division Office on dated 28.03.2022, but payment was not made due to this contractor could not complete the work and it was requested to verify this facts from office of EE M-221, Division PWD (GNCTD). Empowered Committee directed to verify these facts from EE(M-221). Therefore a letter was issued to EE(M-221) from this office seeking clarification vide this office letter no. 5(9)/Class-III(B&R)/ER-2021/ADG(Lko)/2022/5734 dated 15.11.2022. Reply from EE(M-221) PWD (GNCTD) was received in this office on 02.12.2022 vide letter no. 54(717)/पू.भ.अनु. मण्डल एम.221 / लोनिवि / 2022-23 / 3040 dated 30-11-2022 alongwith documentary proof.

Whereas, based on above mentioned facts & records the empowered committee found that contractor has failed to execute the works awarded to him at two occasions and therefore recommended for debarment of contractor in terms of rule no. 13.7 of ER-2022.

And therefore based on the recommended of the empowered committee, the enlistment authority has debarred M/s Dushyant Enterprise, F-479, Sector-9, Vijay Nagar, Ghaziabad (UP)-201009 enlisted contractor of CPWD under Class-III (B&R Category) for a period of six months for tendering in CPWD, in any capacity from the date of issue of this order.
