Whereas, as per Rule 13.6 (n) and 13.6 (t) of the "Rules for Enlistment of Contractors in CPWD 2024", the contractor may be debarred if any of the following is established by enquiry:

- (n) Is considered as not required to be in list of CPWD contactors for any other reason considered fit by the enlisting authority.
- (t) Misbehavior, direct or indirect involvement in threatening, making false complaints, filling legal suites for frivolous reasons, or any behavioral act, omission or commission damaging the reputation of department/ officer.

Whereas, a Show Cause Notice was issued to M/s Dev Horticulture Service vide letter no 25(13)/ADG(PRD)/2021/Class-I (Hort.)/2210 dated 02.06.2025. The reply received by email dated 17.06.2025 (Diary no. 1436 dated 18.06.2025).

Whereas, the reply submitted by M/s Dev Horticulture Service has been considered carefully by the Enlistment Authority.

After carefully considering all the facts & circumstances of the case and the reply submitted by M/s Dev Horticulture Service, the Enlistment Authority hereby debars M/s Dev Horticulture Service from tendering in CPWD Works for a period of Six Months from the date of issue of this order.
