Subject: Debarment of M/s Jai Maa Nursery, enlisted in Class-I (Hort. category), for a period of six months from the date of issue of this order.

Whereas, M/s Jai Maa Nursery is an enlisted Class-I, Horticulture category CPWD contractor vide Enlistment Order No. 15/2022 (Class-I Horticulture) issued vide letter No. 25(13)/ADG(PRD)/2021/Class-I (Hort.)/707 dated 22.02.2022.

Whereas, M/s Jai Maa Nursery participated in two tender but withdraw his tender before award of work.

Whereas, as per Rule 13.6 (n) and 13.6 (t) of the "Rules for Enlistment of Contractors in CPWD 2024", the contractor may be debarred if any of the following is established by enquiry:

- (n) Is considered as not required to be in list of CPWD contactors for any other reason considered fit by the enlisting authority.
- (t) Misbehavior, direct or indirect involvement in threatening, making false complaints, filling legal suites for frivolous reasons, or any behavioral act, omission or commission damaging the reputation of department/ officer.

Whereas, a Show Cause Notice was issued to M/s Jai Maa Nursery vide letter no 25(13)/ADG(PRD)/ 2021/Class-I (Hort.)/1939 dated 16.05.2025. However, the letter was received undelivered and as decided in the Empowered Committee meeting held on 02.06.2025, another opportunity was given M/s Jai Maa Nursery vide letter no. 25(13)/ADG(PD)/2025/2211 dated 02.06.2025. M/s Jai Maa Nursery has replied to the Show Cause Notice vide letter no. Nil dated 10.06.2025.

Whereas, the reply submitted by M/s Jai Maa Nursery has been considered carefully by the Enlistment Authority.

After carefully considering all the facts & circumstances of the case and the reply submitted by M/s Jai Maa Nursery, the Enlistment Authority hereby debars M/s Jai Maa Nursery from tendering in CPWD Works for a period of Six Months from the date of issue of this order.
