OFFICE ORDER

Sub: Debarment of M/s United Company, Puducherry, Enlisted in Class-II (B&R) category from tendering in CPWD Works for a period of two years from the date of issue of this order.

Whereas a complaint has been received from Superintending Engineer and Project Director, Karaikal Project Circle, Karaikal vide office letter No. 23(24)/KPC/2024/605(H) dated 07.11.2024 against the agency "M/s United Company, No.5, Second Cross, Gandhinagar, Puducherry-605009" regarding reason of submission of forged/falsification of documents submitted during arbitration for the work:

"Construction of JIPMER Karaikal New Campus (Phase-I), S.H: Design & construction of compound wall for academic campus 41.75 acres land at Koilpathu at Tirunallar Bye pass & residential campus at Kamarajar salai 38.16 acres of land with Precast Technology at Karaikal"

WHEREAS a Show Cause Notice was issued to M/s United Company, Puducherry vide letter No. 30(1)2025/Vol.-I/SPL.DG/Chennai/586 dated 21/04/2025 under Rule 13.2 of the CPWD Enlistment Rules, 2024, seeking why disciplinary action not to be initiated for falsification of documents.

AND WHEREAS the discrepancies identified in the records submitted by M/s United Company, Puducherry, including cash memos, vouchers, and bank statements, were found to be fake in nature and indicative of forgery, falsification of records, and breach of integrity, as detailed in the Show Cause Notice.

AND WHEREAS M/s United Company, Puducherry have failed to respond to the said Show Cause Notice within the stipulated time of 15 days. The Empowered Committee opined that M/s United Company, Puducherry have nothing to say on this show cause notice and concluded that, the agency has involved in forgery, falsification of records, thereby committing gross violation of ER 2024 and integrity pact.

AND WHEREAS the Empowered Committee, after due examination and as per the provisions of the CPWD Enlistment Rules 2024, concluded that you have violated the following enlistment rules:

- Rule 13.6(e) – Indulged in forgery or falsification of records
- Rule 13.6(k) – Complaints of serious nature have been proved
- Rule 13.6(r) – Breach of Code of Integrity under Rule 175 of GFR-2017

After careful consideration of all the facts placed on record, circumstances of the case and recommendations of the Empowered Committee, the Enlisting Authority found that proposed disciplinary action against M/s United Company, Puducherry is justified as per above mentioned rules.

NOW, THEREFORE, in exercise of powers conferred under Rule 13 of "Rules for Enlistment of Contractors in CPWD 2024", the Enlisting Authority hereby debars M/s United Company, a Class II (B&R) enlisted firm, from participating in any tendering process of the Central Public Works Department (CPWD) for a period of **Two (2) years** from the date of issue of this debarment order.

During this debarment period:

- The firm shall not be eligible to participate in any tenders invited by CPWD;
- The firm's credentials shall not be considered in any upcoming projects;
- No correspondence or representation for revocation of this order shall be entertained before expiry of the debarment period.

This order is issued with the approval of the Enlisting Authority and shall remain in force for a period of **two (2) years** from the date of issue. And this order of debarment shall be deemed to have been automatically revoked on expiry of 2 years from the date of issue of this order and it will not be necessary to issue any specific formal order of revocation.

This issues with approval of SDG Chennai, CPWD.
