Whereas a tender was invited by the Executive Engineer (E), Ranchi-I, CPWD, Doranda, Ranchi, Jharkhand-834002 vide NIT No.67/2020-21/EE(E)/Ranchi-I for the work of Providing separate domestic service connection for various residential building at 2nd Reserve Bn. CISF Ranchi SH: Providing electrical feeder pillar and UG Cable connection for newly installed high Mast Light.

Whereas the financial bid of the above tender was opened on 26.02.2021 and the lowest bidder was Shri Jaleshwar Mahto, Class-IV (Composite) Category Address- Vill & P.O-Sukurhutu P.S-Kanke, Ranchi-834006 (Jharkhand).

Whereas Shri Jaleshwar Mahto, Class-IV (Composite) Category Address- Vill & P.O-Sukurhutu P.S-Kanke, Ranchi-834006 (Jharkhand) had submitted Earnest Money Deposit (EMD) declaration along with their tender, which states that.

- (1) If, after the opening of tender, I/We withdraw or modify my/our bid during the period of validity of tender (including extended validity of tender) specified in the tender documents,
- OR
- (2) If, after the award of work, I/We fail to sign the contract, or to submit performance guarantee before the deadline defined in the tender documents,

I/We shall be suspended for one year and shall not be eligible to bid for CPWD tenders from date of issue of suspension order. “

Whereas Shri Jaleshwar Mahto, Class-IV (Composite) Category failed to deposit the performance Guarantee within the specified period mentioned in the NIT

Whereas a notice was issued to Shri Jaleshwar Mahto, Class-IV (Composite) Category vide letter number.54 (11)/Ranchi-I/2021/3766-67(H) dated.22.03.2021 and letter number 54(11)/Ranchi-I/2021/3835-36(E) dated.30.03.2021 to show cause why action for suspension from bidding in CPWD tenders for a period of one year should not be taken against them on account of violation of EMD declaration.

Whereas no reply submitted by Shri Jaleshwar Mahto, Class-IV (Composite) Category till date.

Therefore I, Er. Manoj Kumar Singh, Executive Engineer(E), Ranchi-I, CPWD, Doranda, Ranchi, Jharkhand-834002 hereby suspend Shri Jaleshwar Mahto, Class-IV (Composite) Category Address- Vill & P.O-Sukurhutu P.S-Kanke, Ranchi-834006 (Jharkhand).from bidding in CPWD tenders for a period of one year from the date of issue of this order.


