OFFICE ORDER

Sub: - Disciplinary action against contractor - Sh. Markandey Rai – Regarding.

Whereas, **Sh. Markandey Rai (Individual)** was enlisted provisionally vide enlistment order bearing office order No. 478 issued vide letter No. 30(1)/ई एंड आर/IV//अ.म.नि.(च.)/547-H dated 05.04.2024.

Whereas, **Sh. Markandey Rai (Individual)** contractor is enlisted in CPWD in Class-IV, in Buildings and Roads Category on 28.06.2024 issued vide office order No. 488 and letter No. 30(1)/ई एंड आर/IV//अ.म.नि.(च.)/989-H dated 28.06.2024.

Whereas, **Sh. Markandey Rai (Individual)** participated in the online tender for the work "Construction of 1 No. Type-VI (Duplex) quarters for ATARI in residential complex ICAR Umiam, Meghalaya" bearing NIT number 27/NIT/CE/SHG/2024-25(2nd call) having an estimated value of Rs. 1,58,19,831/- and last date of submission of tender was 08.11.2024.

Whereas, **Sh. Markandey Rai (Individual)** submitted a provisional enlistment order bearing office order No. 478 issued vide letter No. 30(1)/ई एंड आर/IV//अ.म.नि.(च.)/547-H dated 05.04.2024 having validity upto six months from the date of issue of office order.

Whereas, the provisional enlistment order dated 05.04.2024 was not valid on the date of submission of online tender having last date of submission as 08.11.2024.

Whereas, **Sh. Markandey Rai (Individual)** submitted alongwith the tender documents an Office Memorandum dated 18th October, 2024 issued by Director (Coord & Legal) through file No. 2/3/2024-Legal showing tendering limit of Class-IV as 2.00.

Whereas, a complaint dated 19.02.2025 was received from O/o Chief Engineer, Shillong informing that "a tender was called on 08.11.2024 for an estimated value of Rs. 1,58,19,831/- open to eligible contractors registered with CPWD. Shri Markandey Rai, Class-IV contractor enlisted with CPWD, is permitted to participate only in tenders with an estimated value upto Rs. 1.3 Crores, as per the rules".

Whereas, the document dated 18th October, 2024 submitted by **Sh. Markandey Rai (Individual)** with the tender mentioned above, was verified from issuing authority depicted in the document i.e. Director (Coord & Legal).

Whereas, the issuing authority has stated that the document dated 18th October, 2024 is not issued from their office.

Whereas, it appears to the undersigned that by reason of submitting invalid enlistment document & a forged document at the time of tendering for the work “**Construction of 1 No. Type-VI (Duplex) quarters for ATARI in residential complex ICAR Umiam, Meghalaya**” bearing NIT number 27/NIT/CE/SHG/2024-25(2nd call) having an estimated value of Rs. 1,58,19,831/- and last date of submission of tender as 08.11.2024” **Sh. Markandey Rai (Individual)** violated the rule 13.6(e) of enlistment rules-2024.

Whereas, a show cause notice was issued to **Sh. Markandey Rai (Individual)** vide letter No. 28(525)/ B&R/CL-IV/अ.म.नि.(च.)/का.अभि.(टी.एल.क्यू.ए.)/726-H dated 17.04.2025 to explain the reason to the satisfaction of competent authority why an action for debarment of his existing enlistment with CPWD shall not be taken under rule 13.7 of ER-2024 on account of violation of rule 13.6(e) of enlistment rules-2024.

Whereas, show cause notice was replied by **Sh. Markandey Rai (Individual)** vide letter No 01/CPWD/Legal dated 25.04.2025.

Whereas, the reply of **Sh. Markandey Rai (Individual)**, Contractor in Class-IV (B&R) category has been considered in the empowered committee held on 14.05.2025.

Whereas, Considering the reply of **Sh. Markandey Rai (Individual)**, and facts on record, empowered committee found that the contractor Sh. Markandey Rai has rendered himself liable for action under rule 13.6(e) of enlistment rules-2024.

And therefore, based on the recommendations of the empowered committee, the enlisting authority is pleased to debar the contractor under Rule 13.7 of ER-2024 for a period of six months from the date of issue of this letter. The debarment period would entail the followings:

1. Ban on participating in the tender process in CPWD & PWD (Delhi).
2. Ban on award of contract of works in CPWD & PWD (Delhi).
3. Ban on submitting application for enlistment/revalidation.
4. Ban on change in constitution in his present registration as class-IV (B&R) category.
5. Running contracts shall remain unaffected.
