आदेश / ORDER

विषय: Debarment Order of M/s Nadeem Construction Company, Enlisted in CPWD in Class-IV(B&R) Category.


1. Whereas, Executive Engineer(Noida) has reported to this office dt.31.03.2023, regarding use of manipulated completion certificates by M/s Nadeem Construction Company, in tendering process of STPI, Noida work, invited by M/s NPCC Limited.
2. Empowered Committee under rule no. 13.2 of enlistment rules was formed by the enlistment authority for taking disciplinary action.
3. Whereas a show cause notice was issued to M/s Nadeem Construction Company vide this office letter no. 5(10)/Class-IV(B&R)/ER-2021/ADG(Lko.)/ 2023/2181 dated 03/07/2023.
4. M/s Nadeem Construction Company replied through e-mail dated 18/07/2023, to the show cause notice.
5. Whereas Empowered Committee considered the reply dated 18/07/2023 and found that contractor has admitted the mistake and apologize for the same. Since the matter is of falsification of documents and government documents was forged by contractor to get the work, hence the contractor has committed a crime which would have led to spoil the image of the department and unforgivable, hence Empowered committee recommended to debar the contractor for a period as decided by Enlistment authority under rule 13.7 of Enlistment Rules and to take appropriate action as deemed fit under criminal act of forgery.
6. Whereas undersigned has carefully considered reply dated 18/07/2023 and found that reply given by contractor does not hold in view of falsification done by contractor.

7. Therefore in view of foregoing I, Anupam Agarwal, ADG (Lucknow), CPWD, Enlistment Authority, in exercise of powers under Rule 13.7 of the Enlistment Rules-2022, do hereby debar M/s Nadeem Construction Company, F-253, Sector-23, Sanjay Nagar, Ghaziabad, Uttar Pradesh-201001, enlisted under Class-IV(B&R) Category for a period of **1 Year** from the date of issue of this order. The debarment would entail following:-

- (i) Ban on participation in the tendering process in CPWD and PWD (Delhi)
- (ii) Award of contract for works in CPWD and PWD (Delhi).
- (iii) However, running contracts shall remain unaffected.
