**Subject: Appointment of Independent External Monitor (IEM) in CPWD for implementation of Integrity Pact in CPWD contracts for EPC Projects.**

In order to ensure transparency, equity and competitiveness in public procurement, the Central Vigilance Commission has advised implementation of Integrity Pact (IP) through a panel of Independent External Monitors (IEMs). Therefore, the following provision relating to IEMs is added in the GCC- 2020 for EPC Projects.

The Integrity Pact duly signed by the Engineer-in-Charge in the presence of a witness shall form a part of tender documents uploaded on the e-tendering website.
