OFFICE MEMORANDUM

Sub: Sugamya Bharat - Accessible India Campaign Online Reporting Module

The CPWD Directorate is closely monitoring / reviewing the progress of number of the existing buildings undertaken by CPWD field units under the Sugamya Bharat - Accessibility India Campaign to ensure compliance of all accessibility criteria and completion within stipulated timelines. Therefore, **Sugamya Bharat - Accessible India Campaign Online Reporting Module** has been developed in-house by the e-Gov Unit for online reporting and monitoring of all such works undertaken by CPWD. The module includes the following information -

- (i) Name of Building
- (ii) City of location
- (iii) Concerned CPWD Zone, Division
- (iv) Status of P. E. including date of submission and estimated cost
- (v) Status of AA/ ES including date of issue and sanctioned amount
- (vi) Date of start of work
- (vii) Status of Pre-Access Audit
- (viii) Present status of compliance of each of the recommendations of Access Audit Report based on nine assessment criteria / points
- (ix) Status of Post Access Audit and name of the Post Access Auditor, whose services have been utilized by the EE.
- (x) Percentage of progress and target date of completion
- (xi) Remarks, if any, for non-completion

2. A link to the guidelines for all criteria issued by ADG (Arch.), CPWD (O.M. No. DG/ Arch/39 dated 01.08.2016) is provided in the proforma for the reference of all users.

3. The list of empanelled Access Auditors under Accessibility India Campaign issued by the Ministry of Social Justice & Empowerment vide no. 4-32/2015-A/C, dated 18.02.2016 mentions the validity of one year from the date of issue. The EEs may ascertain the validity of an Access Auditor before engagement for Third Party Post Audit work.

4. The module is accessible through PIMS login. The data would be filled in and edited only by the field EEs. The reports can be generated, viewed and printed by the EEs and concerned senior officers. The report of all Divisions and respective zones, regions can be generated, viewed and printed by DDG (Works), ADG (TD) and ADG (Arch.). The reports can be saved in Excel sheet.
