**OFFICE MEMORANDUM**

**Sub: Preventive Vigilance - Reg. Display of Anti- Bribery and Anti-Corruption Notice.** (Systemic Improvement No. 02/2020)


Central Vigilance Commission (CVC), vide their Circular No. 99/VGL/16 dated 05.06.2009, advised that all the Departments / Organizations should display an Anti-Bribery and Anti-Corruption Notice in English, Hindi as well as in the vernacular language of the area at all prominent locations in its offices. It has been observed these instructions of CVC have not been implemented properly in CPWD.

It is therefore, reiterated that all the Heads of the Offices of CPWD must immediately make arrangement for display of Anti- Bribery and Anti-Corruption Notices at a prominent location in all the offices e.g. Site, Sub-Divisional, Divisional, Circle, Zonal, Regional and DG offices of CPWD **positively by 14th February 2020**, under intimation to this office. The format of notice is enclosed herewith (Annexure-A &B). In case details of SP/CBI are not available, same may be obtained from the Vigilance Unit.

Progress of the above to be monitored by the respective ADG and SDG Units and compliance of the same (along with photographs of the displayed notices at each location) should be submitted by email to this office ([js-cvo.cpwd@nic.in](mailto:js-cvo.cpwd@nic.in)) latest by 21.02.2020 for onward submission to CVC.
