Sub: Filing of Annual Property Return on CPWD web-site-reg.

(Systemic Improvement No. 04/2020) As per Rule 18 of the Central Civil Services (Conduct) Rules 1964 requires all Group – A and Group – B Govt. Servants to submit annual returns of Immovable Property by 31st January of the next year. DoPT OM F No. 11013/7/2014-Estt. A-III dated 05.01.2016 prescribe that Annual Immovable Property Return is required to be filed by all Govt. Servants belonging to Group – A, B, C and erstwhile Group – D. But it is observed that the above instructions are not fully complied by the employees of CPWD. This may be due to un-awareness of rules or forgetting to file the property return in time on CPWD web-site. This causes noncompliance of the Central Civil Services (Conduct) Rules 1964 and also this leads to denial of VCC for certain purposes to the employee.

It is proposed that, a system may be devolved through CPWD website so that a massage may automatically be sent to each employee of CPWD through SMS / e-mail, reminding him to file property return by 31st January and also a scrolling massage may appear on CPWD website to remind each employee to file property return by 31st January.

Submitted for forwarding to the DDG (e-Governance), CPWD Directorate with request to develop such a system in CPWD web-site.
