Subject: Appointment of Independent External Monitors (IEMs) in CPWD for implementation of Integrity Pact in CPWD contracts.

- 1. In order to ensure transparency, equity and competitiveness in public procurement, the Central Vigilance Commission has advised implementation of Integrity Pact (IP) through a panel of Independent External Monitors (IEMs). The IEMs would review independently and objectively whether and to what extent parties have complied with their obligations under the IP. A copy of Circular no. 02/01/2017 dated 13.01.2017 issued by the CVC containing revised Standard Operating Procedure for adoption of IP is enclosed herewith for ready reference.
- 2. Para 5.0 (6) of CPWD Works Manual, 2019 contains provisions relating to adoption of Integrity Pact in General Conditions of Contract. It has been decided to include the provision for IP in all tender documents issued in future in respect of tenders with estimated cost of Rs.300 crore and more.
- 3. The CVC vide letter no.020/VGL/016/452066 dated 04.06.2020 has nominated the following three retired officers as IEM for CPWD works.

- 4. The tenders should specify that IEMs have been appointed by the Central Vigilance Commission. In all tenders, particulars of all IEMs should be mentioned instead of nominating a single IEM in the tender as far as possible.
- 5. Information relating to procurements/contracts covered under IP (ECPT of Rs.300 crore or more) and its progress/status would need to be shared with the IEMs on monthly basis. Hence the Executive Engineers shall send monthly report in the following format by email to cecsq.cpwd@nic.in.
