The Annual Sectoral Review Meeting was conducted by Central Vigilance Commission on 19.09.2016. The CVC has observed that many complaints are being received in the Commission against CPWD officers alleging that the final bills are kept pending unnecessarily on flimsy grounds for a very long duration only to harass the contractors. Instructions have been given to the Vigilance Unit by the Commission to examine this issue to take necessary corrective/preventive actions and submit a report to CVC.
