The matter to be placed on banners and posters/pamphlets during the Vigilance Awareness Week is enclosed herewith.

The following activities are to be observed during Vigilance Awareness Week:

1. Administering the **"INTEGRITY Pledge"** on 30<sup>th</sup> October, 2017 at 11.00 A.M. in their respective offices in the premises of the office in charge. The **"INTEGRITY Pledge"** will be administered by the highest office of the station. Employees may be encouraged to take e-Pledge by visiting the CVC Website. Those who take the pledge verbally may be advised to record it through the Website.
2. Dissemination and publicising through pamphlets to elicit wider participation of all stakeholders and also to encourage their customers/public and corporate firms etc. to take **"Integrity Pledge."**
3. Banner and Poster of big size with bold visible letters in colour shall be printed and be displayed at prominent locations of CPWD Offices including service centres and CPWD residential colonies to attract public attention.
4. Distribution of Pamphlets in Hindi, English & Local language in CPWD residential quarters, CPWD service centres and in local public.

5. Arranging various programmes and competition for all stake holders to promote awareness about vigilance.
6. Interact with clients Residential Welfare Association, NGOs etc.

The theme of this year is "**My Vision – Corruption Free India**" the hindi version of which is "मेरा लक्ष्य – भ्रष्टाचार मुक्त भारत".

Essay writing and Drawing/Painting competitions are being conducted on the above said theme by the Vigilance Unit through various CPWD offices among interested CPWD Staff members and their family members.
