The President is pleased to appoint the Shri Manohar Lal (SC), Assistant Engineer (Civil) [Seniority No.-2052, Date of Birth-19.12.1961] to officiate as Executive Engineer (Civil) in the Central Engineering Service Group "A" temporarily on ad-hoc basis in the pay scale of Rs. 10,000-325-15200/- for a period of one year from the date he assumes charge of the post of Executive Engineer (Civil), or until further orders, whichever is earlier and subject to the final outcome of the Writ Petitions pending in the Delhi High Court [W.P.(C)/840/2003 in the matter of Gurbaaz Singh and others versus Union of India and others] and other court cases etc.

He shall also be required to pass the departmental examination prescribed for Executive Engineer (Civil), if his appointment as Executive Engineer (Civil) is extended beyond the initial period of one year as mentioned in para(1), within a period of 2 years from appointment, failing which he shall not earn second and subsequent increments in the grade of Executive Engineer (Civil).
