**OFFICE ORDER NO. 237 of 2006**

In compliance of Supreme Court judgment/ order dated 19.02.2004 in Civil appeal No. 7498 of 1997 in the matter of Shri R.P. Bhardwaj Vs. Union of India and Others, a limited review DPC to review the proceedings of the regular DPC which met in the month of October, 1994 to consider selection of officers for officiating promotion to the grade of SE(C) in CPWD against the vacancy year 1982 to 1993-94 was held in UPSC. Commission has empanelled Shri R.P. Bhardwaj at Sl. No.1 for the year 1986. S/Shri Pratap Singh (SC), B.K.Chugh, O.P. Bhatia, N.M.D.Jain and Anil K. Mittal have been placed below Shri Bhardwaj in the said panel. The competent authority has accepted the recommendation of the DPC. Consequent upon the review DPC, Shri Bhardwaj has become senior to the above 5 officers in the grade of SE(C).

Accordingly, in partial modification of officer order No. 300 of 1994 (File No.30/15/1994-EC-I), dated 20.10.1994, the position of above officers mentioned at Sl.No.25 to Sl.No.30 of the seniority list of SEs(Civil) issued vide O.M. No. 30/44/1997-EC-I, dated 25.09.1998 will be revised as under:-
