
## OFFICE ORDER No. 108/2008.

Consequent upon the outcome of judgements in O.A. No.3457/2001 and M.A. No.804/2003 of the Hon'ble CAT(PB), New Delhi and CWP No.4283/2003 judgement dated 25.11.2003 of the Hon'ble High Court, New Delhi and SLP No.23133/2004 of the Hon'ble Supreme Court of India, New Delhi and on the basis of the result of the Assistant Engineer (CPWD) Limited Departmental Competitive Examination-1999 held by CPWD Training Institute on 21.02.1999, Director General of Works, CPWD, New Delhi is pleased to appoint the undermentioned Assistant Engineer (Civil), who has been promoted as Assistant Engineer (Civil) on ad-hoc basis vide Office Order No.240 of 2003 Dated 20.11.2003, in the Central Engineering Group 'B' Service on regular basis with effect from the date he took over as Assistant Engineer (Civil) (ad-hoc). He will be on probation for a period of two years with effect from the date he assumed charge as Assistant Engineer (Civil) on ad-hoc basis.
