
## Office Order No. 122 of 2006

The President is pleased to appoint the following Assistant Engineers(Civil) to officiate as Executive Engineer(Civil) in the Central Engineering Service Group 'A' temporarily on ad-hoc basis in the scale of Rs. 10,000-325-15200/- from the date they assume the charge of the post of Executive Engineer(Civil) for a period of one year, or until further orders, whichever is earlier and subject to the final outcome of the Writ Petitions pending in the Delhi High Court(W.P.(C)840/2003 in the matter of Gurbaaz Singh and others versus Union of India and others etc.):-

This ad-hoc promotion will not confer any right on them to any claim either for regular appointment as Executive Engineers(Civil) or for determining seniority in the grade of Executive Engineer (Civil) or any other incidental benefits of regular promotion. They shall also be required to pass the departmental examination prescribed for Executive Engineer (Civil), if their appointment as Executive Engineer(Civil) is extended beyond the initial period of one year as mentioned in para (1), within a period of 2 years from appointment, failing which they shall not earn second and subsequent increments in the grade of Executive Engineer (Civil).
