3. The position in the seniority list will be intimate later on.

4. The Executive Engineers/Superintending Engineers should ensure that no vigilance/disciplinary case is either pending or contemplated against any of the Officers being promoted now before they are relieved to take up the post of Asstt. Engineers (Elect.) on promotion. It may also be ensured that no penalty has been awarded to them, which may stand in the way of promotion. In such event, the fact may be brought immediately to the notice of this Office. A certificate to this effect may also be sent by the controlling officers along with the relieving order of the officers on promotion. The officer-in-charge under whom they are working may ensure that the concerned officer may be relieved within 45 days from the date of issue of this order without waiting for the substitute. Their orders of promotion are liable to be treated to have been withdrawn on the expiry of stipulated period of 45 days. They should join immediately on relief.

5. The Officers under orders of posting and transfers should immediately proceed to their respective places after having been relieved by their superior officers and send two copies of TR-1 Form with their names in capital letters to the Deputy Director, EC-III Section giving reference to these orders. The Officer-in-Charge, under whom they are working should ensure that the concerned officer are relieved immediately without waiting for their substitute.

6. The Junior Engineers on promotion may exercise their option under FR 22-1 (a) (i) for pay fixation within a period of one month from the date they assume the charge of the higher post. However, those who have already got the higher scale as personal to them will neither be entitled to re-fixation of pay nor for exercising the option on promotion. Further, those who have availed ACP Scheme and exercised the option for pay fixation under FR-22-1(a) (i), will not be entitled for exercising this option again on their regular promotion.

7. The Assistant Engineers(civil) under order of promotion are allowed two years period from the date of their joining as Assistant Engineer(Civil) to pass the Departmental Accounts Examination else their second increment at that stage will not be allowed as already intimated vide this Dte's O.M. No. 23/15/1998/EC-III(Pt) dated 04-04-2008.


