3. The Executive Engineers/Superintending Engineers should ensure that no vigilance/disciplinary case is either pending or contemplated against any of the Officers being promoted now on ad-hoc basis before they are relieved to take up the post of Asstt. Engineers (Civil.) on promotion. It may also be ensured that no penalty has been awarded to them, which may stand in the way of promotion on ad-hoc basis. In such event, the fact may be brought immediately to the notice of this Office. A certificate to this effect may also be sent by the controlling officers along with the relieving order of the officers on promotion, The officer-in-charge under whom they are working may ensure that the concerned officer may be relieved within 30 days from the date of issue of posting order by respective ADG without waiting for the substitute. Their orders of promotion on ad-hoc basis are liable to be treated to have been withdrawn on the expiry of stipulated period of 30 days. They should join immediately on relief.

4. The Officers under orders of posting and transfers should immediately proceed to their respective places after having been relieved by their superior officers and send two copies of TR-1 Form with their names in capital letters to the Section Officer, EC-III Section giving reference to these orders. The Officer-in-Charge, under whom they are working should ensure that the concerned officers are relieved immediately without waiting for the services of their substitutes.

5.
