

This ad hoc promotion will not confer any right on him to any claim either for regular appointment as Executive Engineer (Civil) or for determining seniority in the grade of Executive Engineer (Civil) or any other incidental benefits of regular promotion. He shall also be required to pass the departmental examination prescribed for Executive Engineers (Civil), if his appointment as Executive Engineer (Civil) is extended beyond the initial period of one year as mentioned in para (1) above, within a period of 2 years from appointment, failing which he shall not earn second and subsequent increments in the grade of Executive Engineer (Civil).




