Certain categories of contractors who were enlisted/whose enlistment was revalidated under Enlistment Rules 2001, are required to upgrade their capabilities in regard to Banker's Certificate, T&P and Technical Establishment to match with the requirements of Enlistment Rules 2005 read with amendments issued vide O.M. No. DGW/CON/227 dt. 18.1.07, by 31.3.2007. It has now been decided to defer the due date for such upgradation to 31.10.2007 wherever applicable. No further request for deferment will be accepted ,
