

Sub:- Registration as Principal Employer (EE) and Licencing
of contractors under contract Labour (Regulation and
Abolition) Act, 1970.

Dear Sir,

Please refer to your letter No.EDXIII/Cash/Cont.1
543 dated 13.5.1988 on the above subject.

On the basis of the details given by you in your above
quoted letter I am to inform you that the Principal Employer
i.e. the C.P.W.D. is legally bound to take the Registration from
the Licencing and Registering Officer (Assistant Labour
Commissioner (Central) 'B' Block, 2-E-3, Curzon Road Barracks,
New Delhi) wherever 20 or more contract workers are employed
in one establishment of the Principal Employer. It may be
mentioned that these total 20 contract labourers can be
through one or more contractors and it does not matter that
a single contractor may not be employing 20 or more contract
workers. It is sufficient that a total of 20 contract
workers (through contractors) are working in an establishment
of Principal Employer.

As regards supply of manufactured goods it is not
necessary to take any licence or registration. However,
if labour is supplied the registration and licencing will
again be necessary.

As regards the licences to be taken by the contractors
it is clarified that irrespective of the fact whether these
contractors are reputed or not, they are legally bound to
take a licence if they employ 20 or more workmen on any day
in the preceding year.

I have been informed that a large number of contractors who are employing 20 or more workers are being allowed by C.P.W.D. authorities to work without obtaining a licence. By doing so the C.P.W.D. authorities are not only acting against the avowed policy of the Central Govt. to regulate the employment of contract labour and to save them from exploitation but also assisting in the violation of the law of the land particularly in respect of Contract Labour (R&A) Act, 1970. I, therefore, request that you may take immediate and serious steps to ensure that:-

1. Your establishment is registered with the competent officer i.e. the Assistant Labour Commissioner (Central) New Delhi immediately.
2. The contractors working under you who employ or supply 20 or more contract labour are compelled to take licence from the Licencing Officer (Assistant Labour Commissioner (Central)) without any further delay.

A copy of this letter is again being endorsed to Director General (Works) for issuing necessary instruction to you as well as other officers.
