MEMORANDUM

Subject: Revalidation of enlistment of Contractors in CPWD - Contractors enlisted in Class II to V.

Ref. : This Directorate Memo No.DGW/CON/77/A & C dated 12th December, 1994.

Vide O.M. referred to above, instructions were issued that the procedure adopted for revalidation of enlistment of Class I contractors will be followed for revalidation of Class II and III contractors also. It was also stated that the existing enlistment of contractors in Class II and below will continue to be valid upto 30.6.95.

- 2. Representations have been received that it may not be possible to complete the revalidation exercise for contractors of Class II and below categories by 30.6.95. It has, as such, been decided that the existing enlistment of such contractors will continue to remain valid till 30.9.95. It has to be ensured that revalidation exercise for such contractors is completed and the contractors are informed about it before 30.9.95.
- As regards the procedure for revalidation of enlistment of Class II. & III contractors (similar to that adopted for Class I contractors), it is informed that the performance of 'the Contractors will be evaluated on marking system as per Evaluation Sheet, specimen enclosed (Annexure I). There will be separate evaluation sheet for each completed work indicated by the contractor in his application form. The overall grading of the contractor will be based on the average of the marks for all the completed works. It should be ensured that the evaluation is done carefully, checked and endorsed as "checked" by staff entrusted with this The revalidation of the contractor's enlistment, in the category in which he is originally enlisted, will be done if he secures 35 or more marks (out of 100) in the overall grading, and will be applicable for a period of 5 years from the date of issue.

- of different Processing of applications nature will be done as indicated in Annexure II. will contractors be informed individually depending on the nature of the case as per column 4 of Annexure II. Since at this stage, revalidation exercise is being done in bulk, consolidated list of each category, may also be issued, as done for class I contractors. In future, however, cases may be processed at the appropriate time, for which review may be done at the beginning of every month and contractors are asked to apply for revalidation at least 6 months before the due date.
- 5. As already stated in O.M. referred to above, the procedure for revalidation of the enlistment of class IV & V contractors should be simple on the basis of 'satisfactory' performance on the works completed/in progress by them.

OFFICE ORDER NO. 670 (B 42)

With reference to their application; DG(W), CPWD, New Delhi is pleased to revalidate enlistment of the contractors as in the enclosed list in Class I(Building & Road Category) of this Department as notified in the Department's orders noted against each. They shall be eligible to tender for CPWD works in the above category in the whole of the Indian Union, for a specified limit as prescribed from time to time, for a period of five years, without prejudice to the rights of the Department to prescribe/modify the limits of tendering. This is also subject to their meeting the eligibility criteria laid down in O.M. No.DGW/Con/75 dated 27.10.94 or any further amendments thereof made from time to time.

- 2.(a) They shall be required to deposit earnest money with each tender as per terms and conditions of the tender/agreement.
- 2.(b) Security Deposit will be recovered from their bills in accordance with the rules in force from time to time.
- 3. They may, if they have not already deposited and if they so desire deposit Rs.3,00,000/- with the Director Ceneral Works and secure exemption from the payment of earnest money after executing necessary bond. This deposit will exempt them from payment of earnest money with each individual tender but security deposit will be recovered from their bills in accordance with rules in force from time to time.
 - 4. They shall be required to continue to have a permanent Engineering Organsiation capable of dealing with works of large magnitude in all stages. They shall be required to intimate changes in their Engineering Staff as and when such changes are made.
 - They will employ the required technical staff as per terms and conditions of each contract agreement.

- 6. They shall have to abide by the terms and conditions of the contract as they stand or as may be altered from time to time.
- 7. They shall have to apply to the Income Tax Officer of the area in which they are assessed for grant of Income Tax Clearance Certificate in the month of May every year. The Income Tax Clearance Certificate in original or a copy thereof duly attested by a Gazetted Officer or a Notary Public should be submitted to this office by the end of June every year. If they fail to submit the ITCC or fail to show any justified reasons for non-submission /from /of the ITCC the approved list of contractors.

- 8. They shall not enter into any fresh partnership or modify the existing partnership/sole proprietor
 ship without the prior approval of the Department.
 In case, they wish to enter into any partnership
 they must intimate in advance the full details of
 the new partners, their relationship with existing
 partners, if any, alongwith the draft of the proposed
 partnership deed. Any departure from this will
 render the contractors liable to be removed from
 the approved list of contractors of the Department.
- 9. They shall be issued tender on production of valid Income Tax Clearance Certificate in the name & style in which the contractor is registered bearing the name/names of Sole Proprietor/Partners as notified in the enlistment order.
- 10. They shall not be permitted to tender for works in the CPWD Circle responsible for award and execution of contract in which their near relative is posted as Divisional Accountant or as an officer between the grades of SE & AE (both inclusive). They should also intimate to this office the names of persons who are working with them and who are near relatives of any Gazetted Officer in Central Public Works Department or in the Ministry of Urban Development. Any breach of this condition by the contractors will render them liable to be removed from the approved list of contractors of the Department.
- 11. The revalidation of enlistment notified in this order is valid for a period of 5(Five) years from the date of issue. The contractors will be required to apply for revalidation of their enlistment 3 months before the expiry of their enlistment. In case they fail to execute any work during this period, the enlistment of the contractors is liable to be not revalidated.

- They shall also intimate the change in their permanent address, if any, in future. In case they fail to intimate such change to the Department, their names would be removed from the approved list of contractors.
- They shall be bound by the enlistment rules of this Department as amended from time to time.
