## Sub: Sanctioning of extra/substituted/deviation of items -regarding

Following amendments are hereby made in the provisions of CPWD Works Manual 2007.

## 1(a) **Existing Provisions**

Para 23.1.2 (2) The amount of a deviation statement shall be algebraic sum of deviation amounts of all individual items.

(b) Modified provisions The amount of a deviation statement shall be the sum of absolute value of deviated amounts of all individual items.
