Subject: Assistance to Labour Co-operative Societies - Award of works without call of tenders.

The powers given to officers of CPWD to award the works to registered Labour Co-operative Societies were last revised vide O.M. No. DGW/MAN/78 dated 11.12.2001. Due to increase in cost of works since issue of this O.M., the matter for revision of powers was under consideration of MOUD. The

Ministry has since approved the proposal and accordingly the powers are revised as under:-

2.	Award of works at current market rates provided the same are certified as reasonable by the officers of CPWD without call of tenders.  E.E. – upto Rs. 1.00 lacs  S.E. – upto Rs. 2.00 lacs	Award of works without call of tenders/quotations at current market rates provided the same are certified as reasonable by the officers of CPWD. E.E. – upto Rs. 1.5 lacs S.E. – upto Rs. 3.00 lacs
3.	Society will be exempted from payment of earnest money for works estimated to cost upto the limit of Rs. 2.0 lac. Societies will however pay security deposit by way of percentage deductions from their bills	Society will be exempted from payment of earnest money for works estimated to cost upto the limit of Rs. 3.0 lac. Societies will however pay security deposit by way of percentage deductions from their bills
4.	The frequency of payment may be fortnightly provided there is appreciable progress on the work and the value of work is not less than Rs 20,000/-	The frequency of payment may be fortnightly provided there is appreciable progress on the work and the value of work is not less than Rs.30,000/-
5.	Other rules and regulations will remain the same.	Other rules and regulations will remain the same.

The provisions contained in O.M. No. DGW/MAN/78 dated 10.12.2001 and provisions contained in Works Manual 2003 stands superseded accordingly.
